**NOTICE OF APPEAL BY DEBTORS FROM ORDER GRANTING EMERGENCY

RAYMOND P. FINK, JAMES M. KRASNO AND WILLIAM L. RUTHERFORD TO  
COMPEL CONTINUED PROCESSING OF PILOT PENSION APPLICATIONS AND  
PAYMENT OF NON-QUALIFIED PENSION BENEFITS**
